### How to Participate

---

2. Present your receipts at the information desk & sign up to the NTC e-newsletter database.

Personalised bookmarks are available on the following days & times:

Thursday 9 May: 10am – 2pm & 5pm- 8pm

Friday 10 May: 10am – 4pm

Saturday 11 May: 10am – 5pm

### General Terms and Conditions for Promotions

3. Strictly limited to 200 bookmarks per day.
4. Entries are valid if they meet all the entry requirements as outlined in individual promotion entry terms and conditions.
5. Purchases at supermarkets, fresh food retailers, restaurants, cafes and food court retailers plus alcohol or tobacco are excluded from the promotion.
6. Receipts must be dated during the Promotion period (1 – 11 May) and receipts outside of these dates will not be accepted. Multiple receipts which add up to the minimum \$50 spend will be accepted, provided all receipts are from the same day.
7. \$50 spend equates to one bookmark. i.e. \$100 spend equates to 2 bookmarks. Maximum of 2 bookmarks per person during the promotional period.
8. To redeem customers present their receipt/s to the Information desk during the operational times of the personalization station only. This is Thursday 9 May 10am – 2pm & 5pm – 8pm, Friday 10 May 10am – 4pm and Saturday 11 May 10am -5pm
9. To redeem the customer is required to sign up to the NTC e-newsletter database to be eligible to receive a bookmark.
10. If the customer is under the age of 18 the gift must be accepted by a parent or legal guardian.
11. Employees of Narellan Town Centre (Dart West Retail Pty Ltd) or their spouses\* who have been associated with the centre for any time since the commencement of the promotion, are eligible to participate.
12. Staff working in retail stores in Narellan Town Centre are eligible to participate.
13. Contractors of Narellan Town Centre are eligible to participate.

*\*Spouse - Definition of word 'spouse' in relation to promotions conducted by Narellan Town Centre – known couple, whether by marriage or defacto relationship, living under the same roof at any time during the promotion.*
